### **Tuition Grant Scheme for Polytechnic Students**

The MOE Tuition Grant (TG) Scheme was introduced by the Government to help students enrolled in full-time Diploma programmes defray the costs of tertiary education in Singapore.

- Singapore Citizens will be automatically awarded a Tier A TG, which is the highest level of subsidy, upon successful
  enrolment into the Polytechnics as long as they have not benefited from TG previously to complete a course at the same
  or higher level of education.
- Singapore Permanent Residents (SPR) may apply for a Tier B TG if they have not benefited from TG previously to complete a course at the same or higher level of education. SPR who are granted TG are required to secure employment and serve in a Singapore entity for three years upon graduation. Students can apply for TG upon successful enrolment into the Polytechnics.
- International Students may apply for a Tier C TG if they have not benefited from TG previously to complete a course at
  the same or higher level of education. International Students who are granted TG are required to secure employment
  and serve in a Singapore entity for three years upon graduation. Students can apply for TG upon successful enrolment
  into the Polytechnics.

Students who choose not to apply for TG, or are not awarded TG, will need to pay full Tuition Fees. Students can approach the Polytechnics directly for more information.
