## Notebook Grant Scheme (NEU PC Plus Programme)

With infocomm devices in their hands, students can now have easy access to lesson notes, online lectures and many other learning tools to aid their schoolwork and projects.

## What to Submit

2. Photocopy of both sides of Applicant and all household members' NRICs (for children below 15 years old, Birth Certificates are acceptable)	
3. Photocopy of admission cards for family members studying in Poly/ITE/University	
4. Photocopy of NS Enlistment letter or enrolment letter for family member who is awaiting for NS or entry to Poly/University respectively	
5. Relevant medical documents/ doctor's verification of the applicant's or family member's disabled condition (if applicable)	
6. For all working adults in the household, payslip or CPF contribution history for the last 3 months.	
7. For all self-employed members in the household, latest income tax and CPF contribution for the last 3 months.	
8. For working adults who do not have fixed monthly salary, the last 3 months payslip or CPF contribution history for the last 3 months (where applicable)	
9. For non-working adults in the household, CPF contribution history for the last 3 months and declaration in Annex A.	
10. For those who are self-employed/non-employed/have other sources of income, the declaration in <u>Annex A</u> respectively (where applicable)	
11. For those who have current broadband subscription and do not need to subscribe the 3-years broadband through TP, the declaration form in Annex A.	

## Other Information

1. Temasek Polytechnic reserves the right to ask for additional documents to support the application.
2. IMDA reserves the right to amend the terms & conditions as and when it deems necessary.
