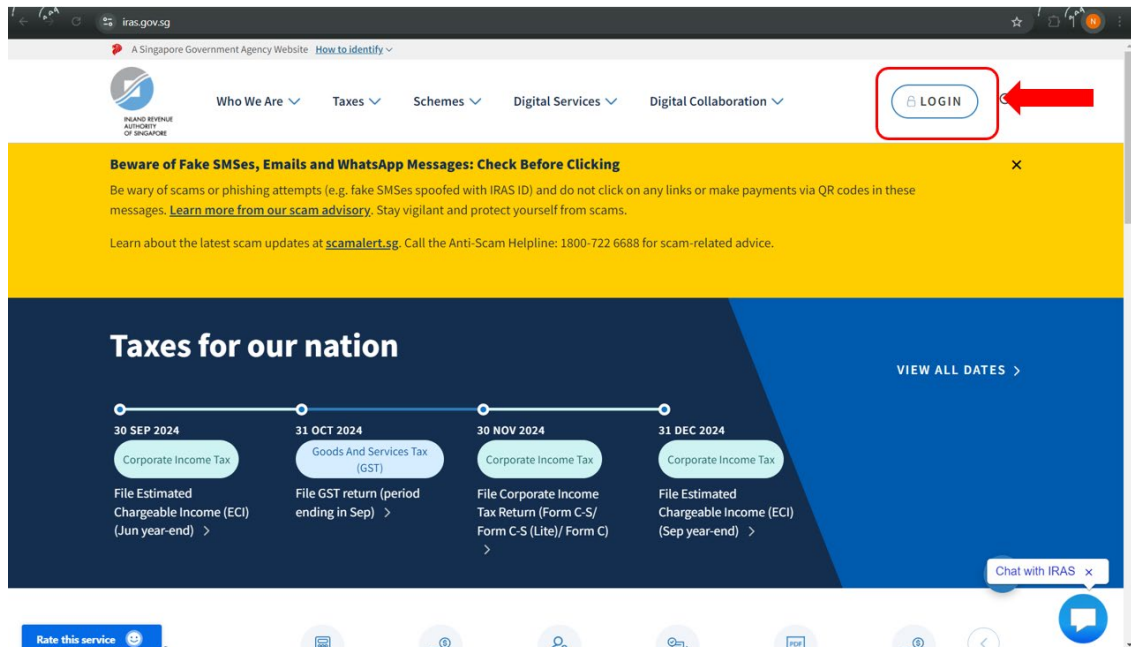
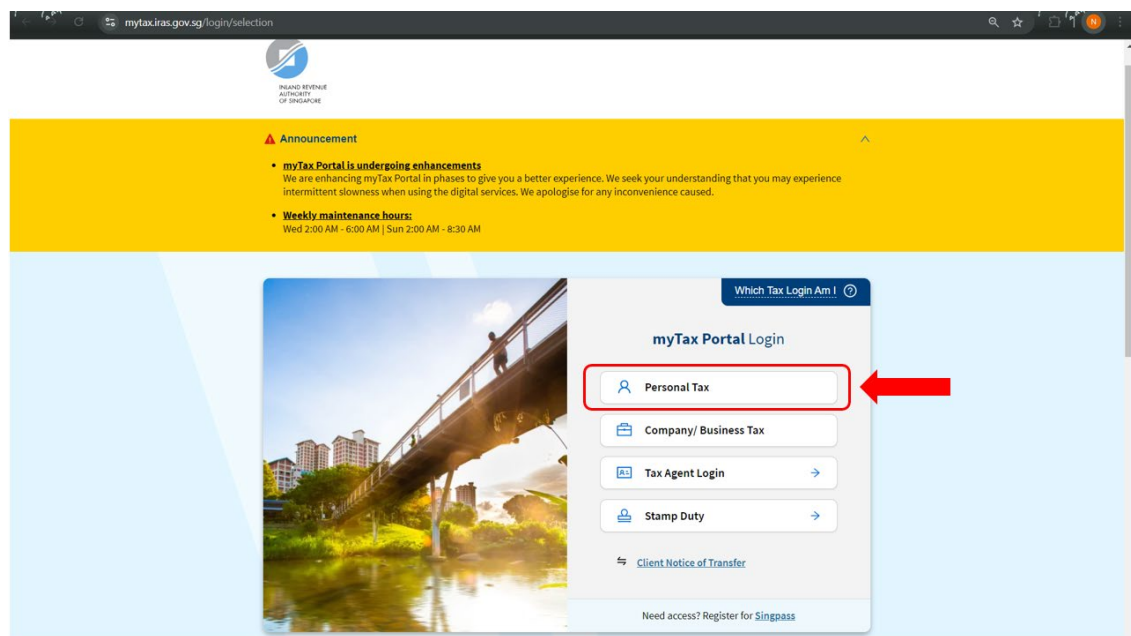

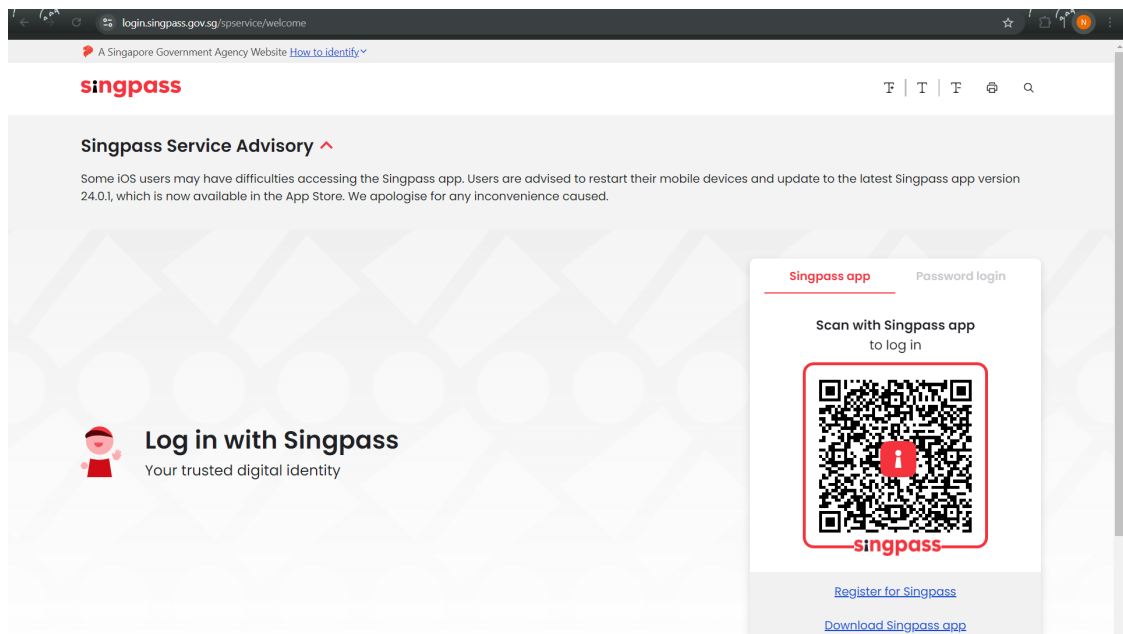
1. Launch your web browser, type in www.iras.gov.sg and click on the login button on the top right-hand corner.



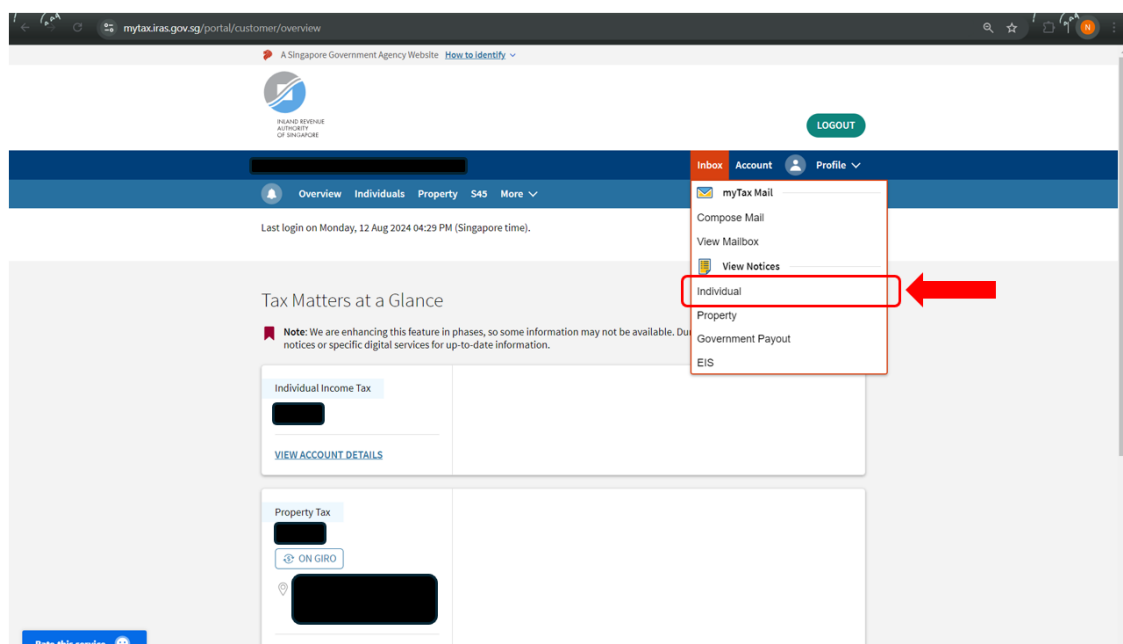
2. Click on 'Personal Tax'.

- Self-employed income (e.g. as a commission agent) with an annual net business income that exceeds \$6,000; or
- Gross rental income (before deducting rental expenses) that exceeds \$22,000; or
- Other sources of income (e.g. withdrawals from Supplementary Retirement Scheme) that exceeds \$22,000.

More than one source of income

- Total income exceeds \$22,000 (e.g. employment and gross rental income); or
- Annual net business income exceeds \$6,000 (e.g. hawker, commission agent).

What do you need to do?

To file a tax return,

- Log in to mytax.iras.gov.sg using your Singpass from **1 Mar to 18 Apr** of each year.
- Select "Individuals" > "Filing Matters" and "[File Income Tax Return](#)".

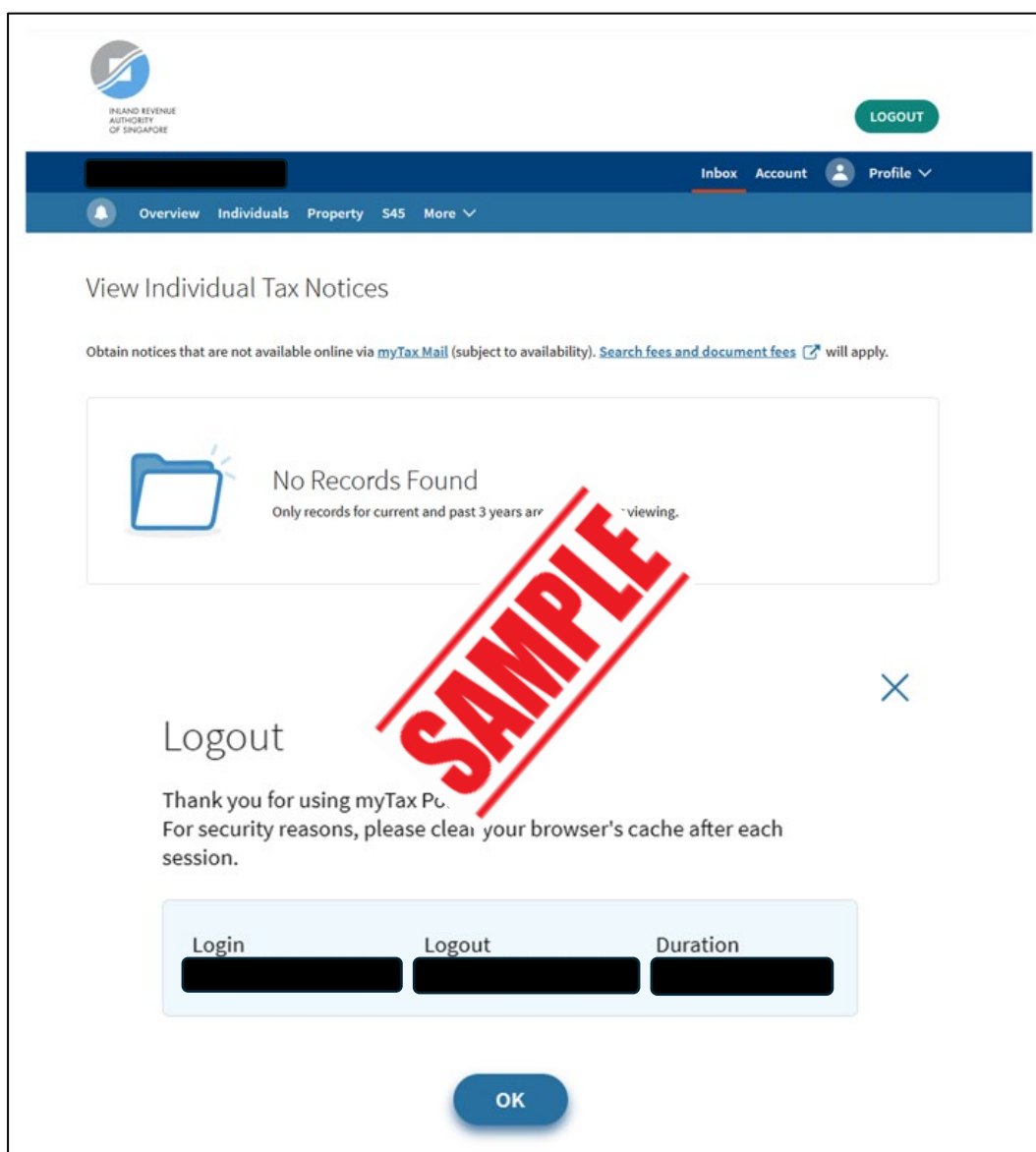
